**Guidelines:**

1. Applicants must bring their own table/chairs/tents/booths; etc...the Sowebohemian Festival does not supply these.
2. The Festival Planning Committee will assign your vending space on the festival grounds.
3. Vending Spaces must be set up by 11:30 am on the day of the festival, Sunday, May 29, 2011.
4. Tear down of your space should not begin before 7:00 p.m. on Sunday, May 29<sup>th</sup>, 2011 (weather permitting).
5. NO VENDOR VEHICLES ARE PERMITTED ON FESTIVAL GROUNDS BETWEEN 11:30 AM AND 7:00 PM DURING THE FESTIVAL ON SUNDAY MAY 29<sup>TH</sup>, 2011
6. Vending Spaces MUST be left clean. Trash must be disposed of in festival cans. Our neighbors appreciate these efforts.
7. Incomplete or illegible applications may have to be resubmitted. The festival committee reserves right to deny any application.
8. No Alcohol Beverages may be brought for personal use or sales by vendors. (Please understand that the Sowebohemian Arts and Music Festival uses ALL proceeds from alcohol sales to put on the festival each year as well as to support neighborhood schools and nonprofit organizations. No one is getting rich from this but each beverage you purchase helps to support the arts in our neighborhood, and ensuring that the festival can continue each year.) Alcohol may be purchased on site from designated beer and wine trucks, failing to comply with this can result in expulsion from the festival.
9. There is a \$20.00 penalty for bounced checks.
